The position of firefighter is a highly visible position within the community served and possession of a strong moral character is required. Fire District No.1, County of Leavenworth is a non-transport, otherwise full-service fire department responding to all types of emergencies. Current Work Schedule: A twenty-four-hour work period is utilized based upon the Berkeley schedule: 24 on 24 off, 24 on 24 off, 24 on 96 off.

Minimum qualifications to be considered:

- High school diploma or G.E.D. equivalency
- 18 years of age by the first day of employment.
- Must possess a valid driver's license and maintain an insurable driving record.
- Kansas Emergency Medical Responder certification or National Registry Emergency Medical Responder with the ability to gain Kansas certification within 60 days of employment. *Kansas Emergency Medical Technician Certification must be obtained within 18 months of hire date as a condition of employment.*
- Firefighter I & II certification
- Hazardous Materials Awareness and Operations Level
- Ability to obtain Driver Operator-pumper within one-year of hire date.
- Current Health Care Provider BLS CPR/AED.
- NIMS/ICS 100, 200, 700 and 800.
- Successful completion of the Candidate Physical Ability Test (CPAT)
- Fire Service Entrance Exam (FSEE) with a minimum score of 70%

- All Required Certifications must be maintained as a condition of employment. IFSAC and Pro-Board certifications are considered equivalent. All IFSAC and Pro-Board certifications must have the appropriate number and seal on each certification provided.

Process:

- The application process is ongoing until all positions are filled. Applicants will be reviewed periodically. **The application packet must include the following to be considered for this position:**
 1. A completed Fire District #1 application. The application is available on the district's website: www.fd1lvco.org . An application can also be obtained at FD No. 1, Station 1, located at 111 E. Kansas, Lansing, Kansas 66043.
 2. A copy of your Candidate Physical Ability Test (CPAT) certification.
 3. A copy of your Fire Service Entrance Exam (FSEE).
 4. Copies of IFSAC Firefighter I, II
 5. Copies of IFSAC Hazardous Materials Awareness, and Operations
 6. A copy of your current EMR or EMT certification and BLS provider CPR/AED
 7. A copy of your NIMS/ICS 100, 200, 700, 800 certificates.

Salary and Benefits:

- Entry Level Probationary Firefighter Starting Pay: \$42,897 Annually
- After successful completion of 1 year probation: \$46,135 Annually
- Health and dental insurance. Employee pays 15% and Employer pays 85% for individual and family.
- Vision insurance, 100% paid for by the employee.
- State sponsored defined pension plan (KP&F) Kansas requires 15 years of service to be vested.
- Supplementary 457(B) retirement system available
